SUBJECT: 2009-11 Structural Deficits

At your request, I have prepared a table, which shows the estimated structural deficits of the state's general fund for the 2009-11 biennium. In addition, the table shows the structural deficits for the previous six biennia.

The structural deficit reflects the amounts necessary (through revenue growth, or revenue and appropriations modifications) for the ensuing biennium to produce a balanced budget.

For the 2009-11 biennium, amounts are shown under the 2007-09 biennial budget (2007 Act 20), and for each proposal under the 2007-09 budget adjustment bill (March SS AB 1 and the enacted bill (2007 Act 226).

As shown on the table, at the time of enactment of 2007 Act 20, the 2009-11 structural deficit was projected to be \$896 million. Under each of the budget adjustment proposals that number has increased significantly. The primary reason for this is due to the estimated decline of general fund tax revenues in the base year (2008-09) of the current biennium. The February 13, 2008, revenue estimates of this office reduced those projected tax collections by \$355 million in that year. Thus, going into 2009-11, base revenues are reduced by \$355 million annually, or \$710 million for the biennium. In addition, the combination of increased sum sufficient appropriations and reduced departmental revenues (primarily due to reduced interest earnings) affected 2008-09 by approximately \$40 million. Carried into the next biennium, this \$40 million increases the structural deficit by \$80 million (\$40 million in each of 2009-10 and 2010-11). In summary, the \$896 million projected structural deficit for 2009-11 at time of enactment of 2007 Act 20, increased by \$790 million to \$1,686 million without any gubernatorial or legislative action.
