

MTI Election Results

MTI's Election Committee has tallied the ballots cast in last week's MTI teacher bargaining unit general election and has certified the election of MTI officers Mike Lipp (West) as President-elect; and the re-election of incumbent Art Camosy (Memorial) as Vice-President; incumbent Fred Rosevear (East) as Treasurer; and incumbent Elizabeth Wingert (Elvehjem) as Secretary. All will be installed at the May 21 meeting of the MTI Faculty Representative Council. President-Elect Peggy Coyne (Black Hawk) will also be installed as President for the ensuing school year at the May 21 Council meeting. Current President Kerry Motoviloff (Doyle) will remain on the Board as Past-President. The MTI Board of Directors consists of ten members - the six abovereferenced officers who are elected by the general membership and four at-large representatives elected by the MTI Faculty Representative Council.

Elected to the MTI Bargaining Committee are: Elementary School Representative - **Kerry Motoviloff** (Doyle); Middle School Representative - incumbent **Peggy Coyne** (Black Hawk); High School Representative -**Andrew McCuaig** (La Follette); At-Large Representative - **Andrew Waity** (Crestwood); and Educational Services Representative - incumbent **Holly Hansen** (Falk). The MTI Bargaining Committee consists of 15 members. One from each of the referenced areas is elected each year.

National Teacher Day: A Day for the Governor & Legislators to Step-up for Children, Teachers & All Other Public Employees



Wisconsin's Governor continues to take advantage of public school employees and continues the erosion of quality education by continuing the revenue controls on school boards, and by increasing his attack on public schools by imposing even greater reductions in funding. *The Governor's proposed budget takes another \$8.8 million from the MMSD Budget; and that is in addition to the loss of many more million dollars should voucher schools be expanded to Madison.* Walker's proposals enable the State to usurp every school board's authority to operate their local school district at the quality the public demands. May 7 is National Teacher Day. It is supposed to be a time for honoring teachers and recognizing the lasting contributions teachers make in society and in the lives of children.

The celebration is dampened by school boards across Wisconsin being forced to cut staff and programs. Wisconsin public education is being destroyed by the Governor and by legislators more interested in privatizing education rather than continuing excellence in public education. Public schools endure the constant scrutiny of test results, while voucher schools remain unregulated. Class sizes are far higher than the size mandated for optimal learning. Classes for accelerated learners have been eliminated and special education has gone from being specialized for students' disabilities to being generalized. There is not enough funding to clean classrooms on a daily basis, including those for pre-K and kindergarten, which means food and drink spills and general uncleanliness resulting from normal activities of younger students.

MTI "Patch Through" Voucher Phone Bank May 9

Thanks to the volunteers who helped make phone calls at MTI on April 23. With few volunteers, 51 callers were "patched through" to leave a message for Senator Sheila Harsdorf that *voucher expansion is bad for Wisconsin and that public schools must be fully funded*. **The Governor's proposed budget will take \$96 million** from public schools to fund private and parochial "*voucher*" schools and private charter schools.

This program was a great success in other Senate Districts as well, generating well over 200 contacts last week. Any member interested in giving this a try, another night of calling is being considered for *Thursday, May 9*, 4:30 - 7:30 p.m., at MTI. The constituents we are calling are targeted based on their likelihood to respond positively and include WEAC members and voters favorable to public schools. This fight is critical because if we lose, voucher schools will be coming to Madison, whether we want them or not, with slick marketing campaigns designed to lure tax dollars into their pockets by denigrating our public schools. *Don't let this happen!* We need seven confirmed volunteers to make this set-up worthwhile.
