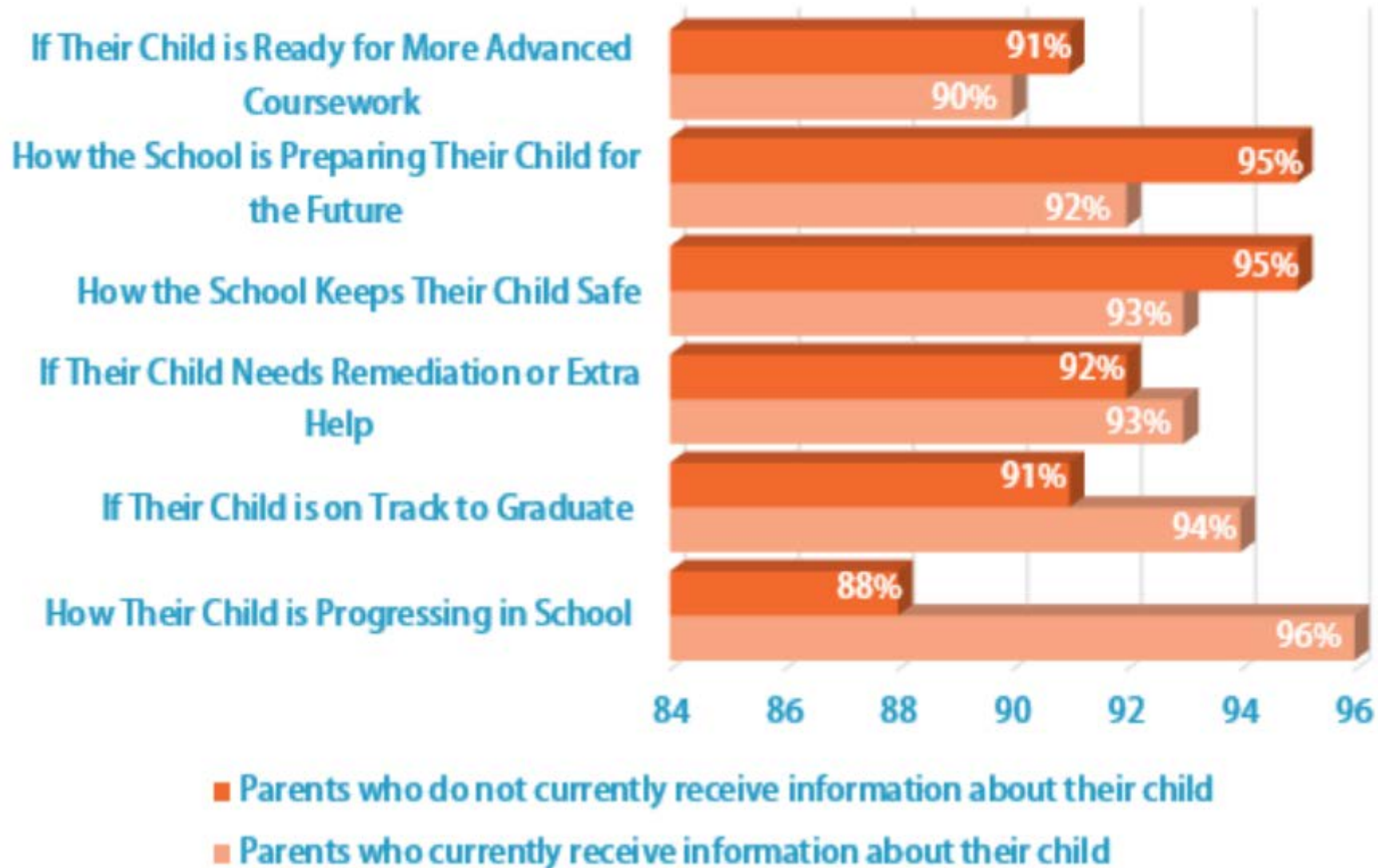

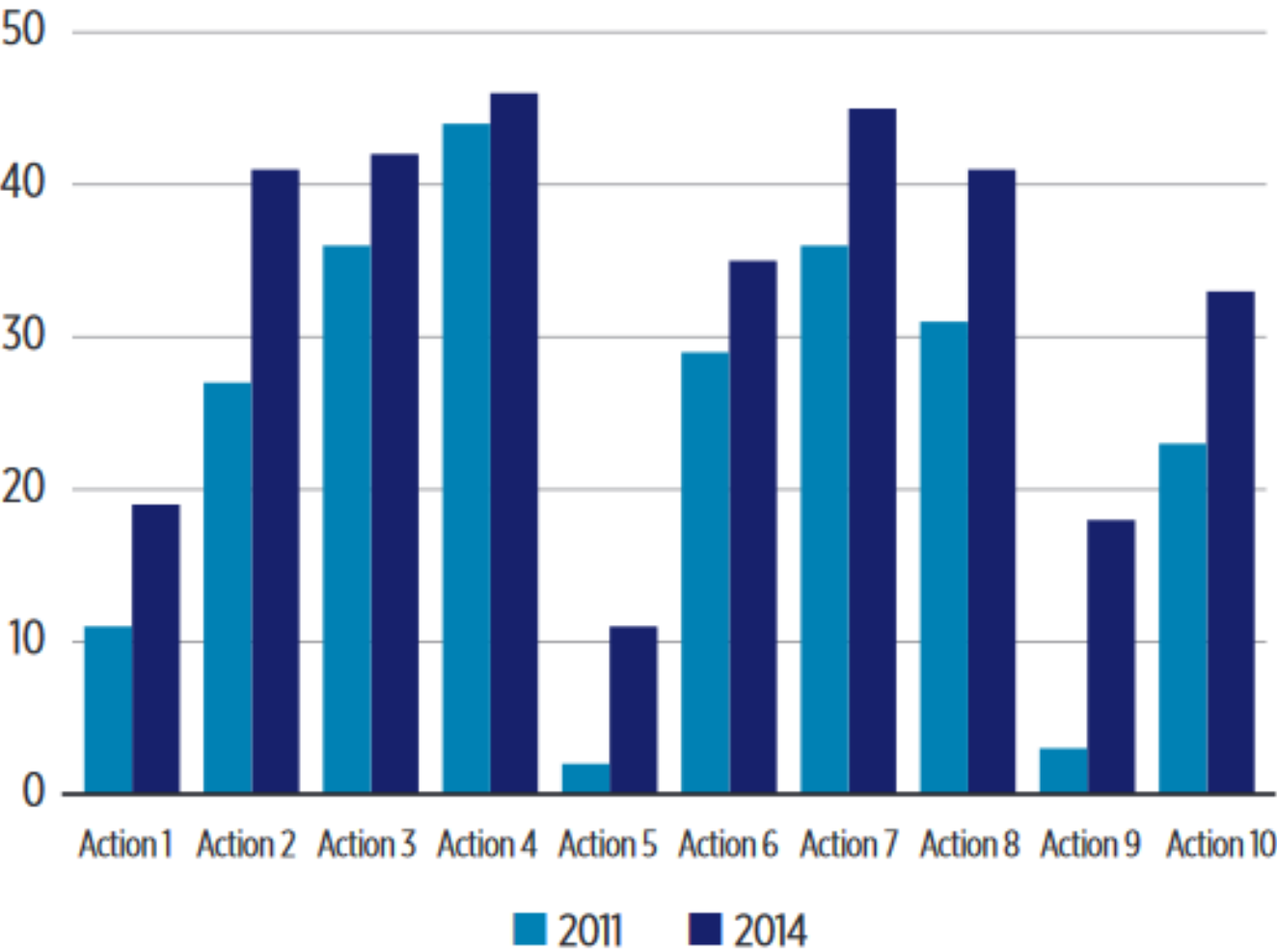




State Landscape

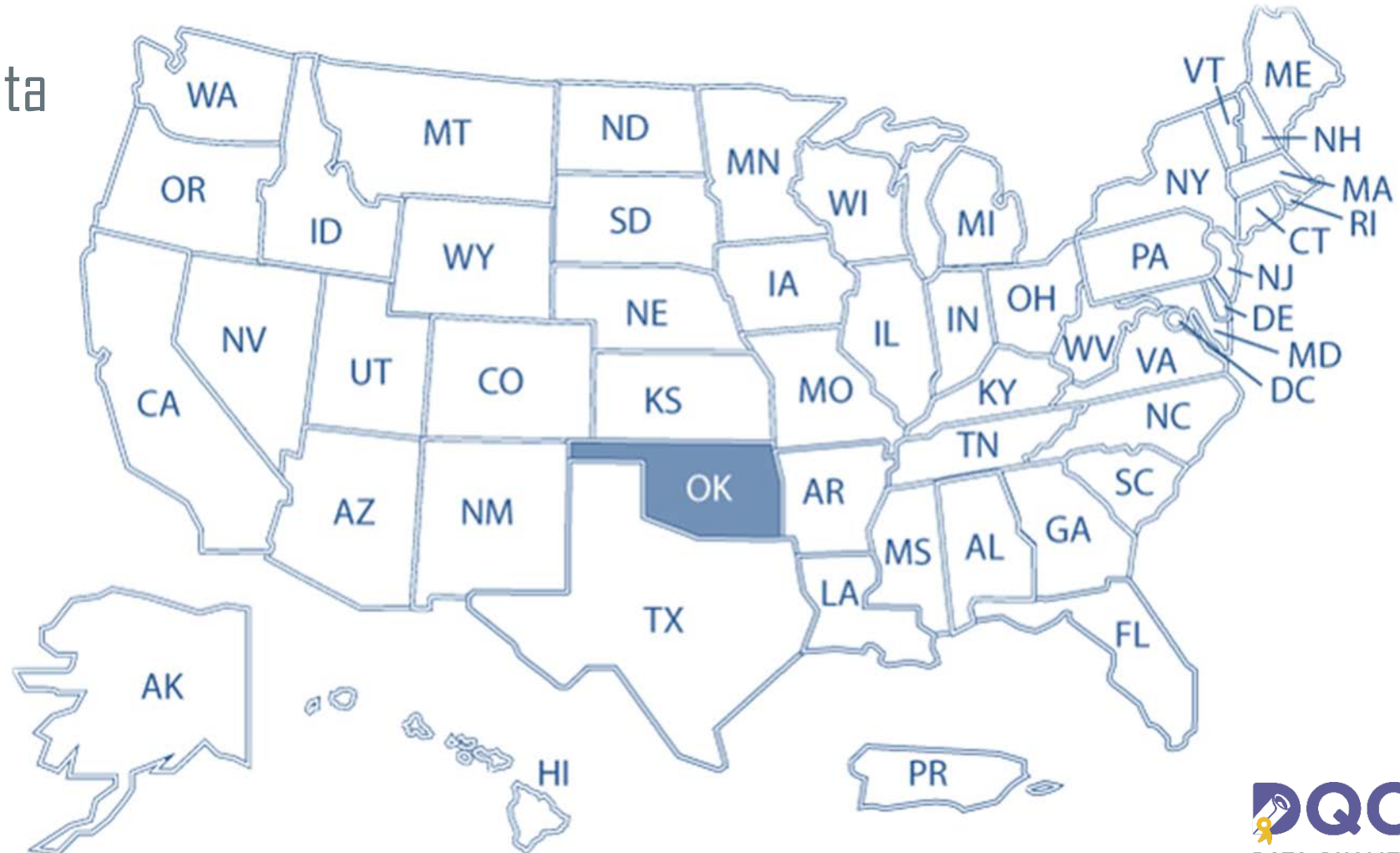
State Landscape

2013 State Legislative Activity

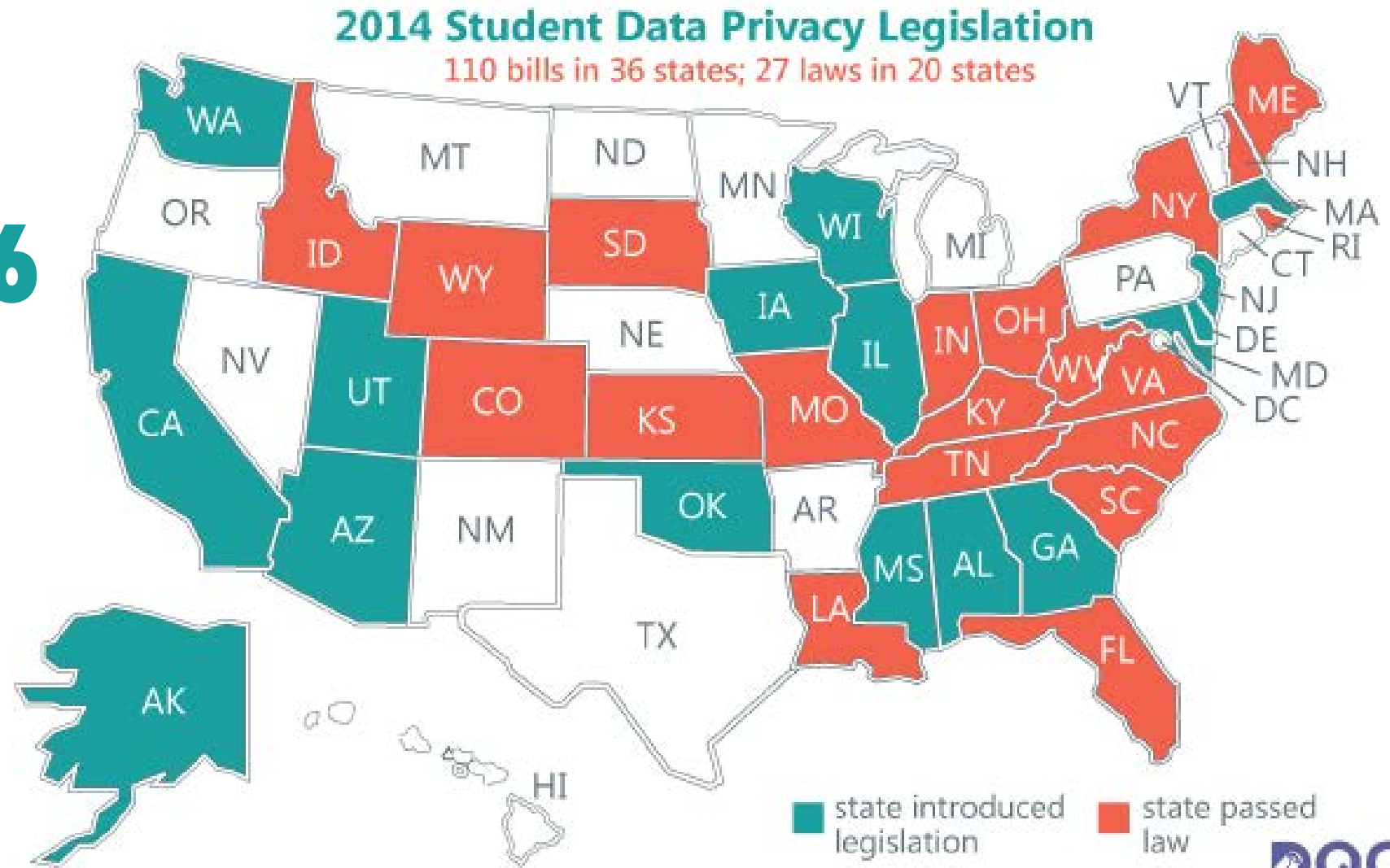
1 bill related to student data

states.

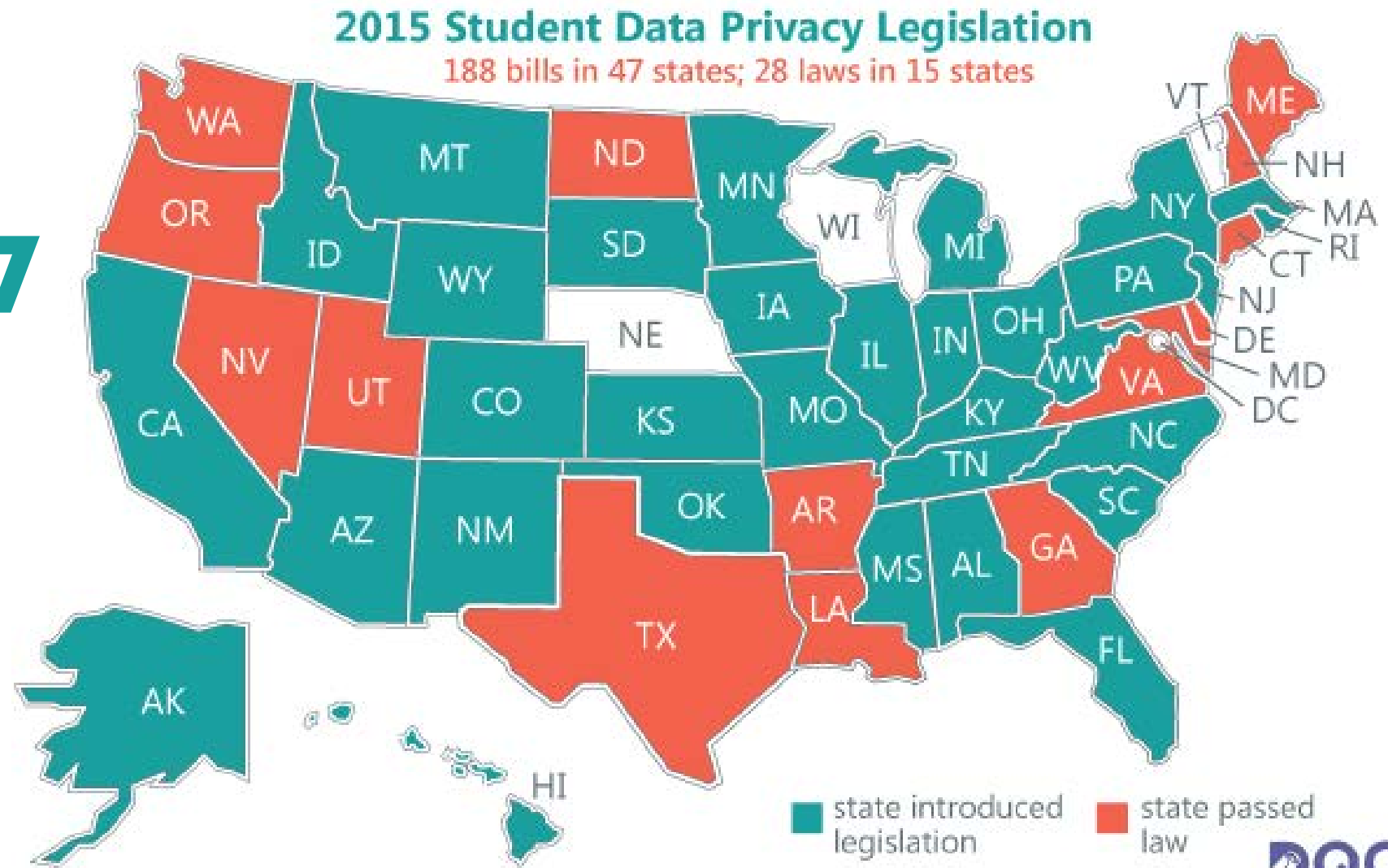
27 laws passed in

states.

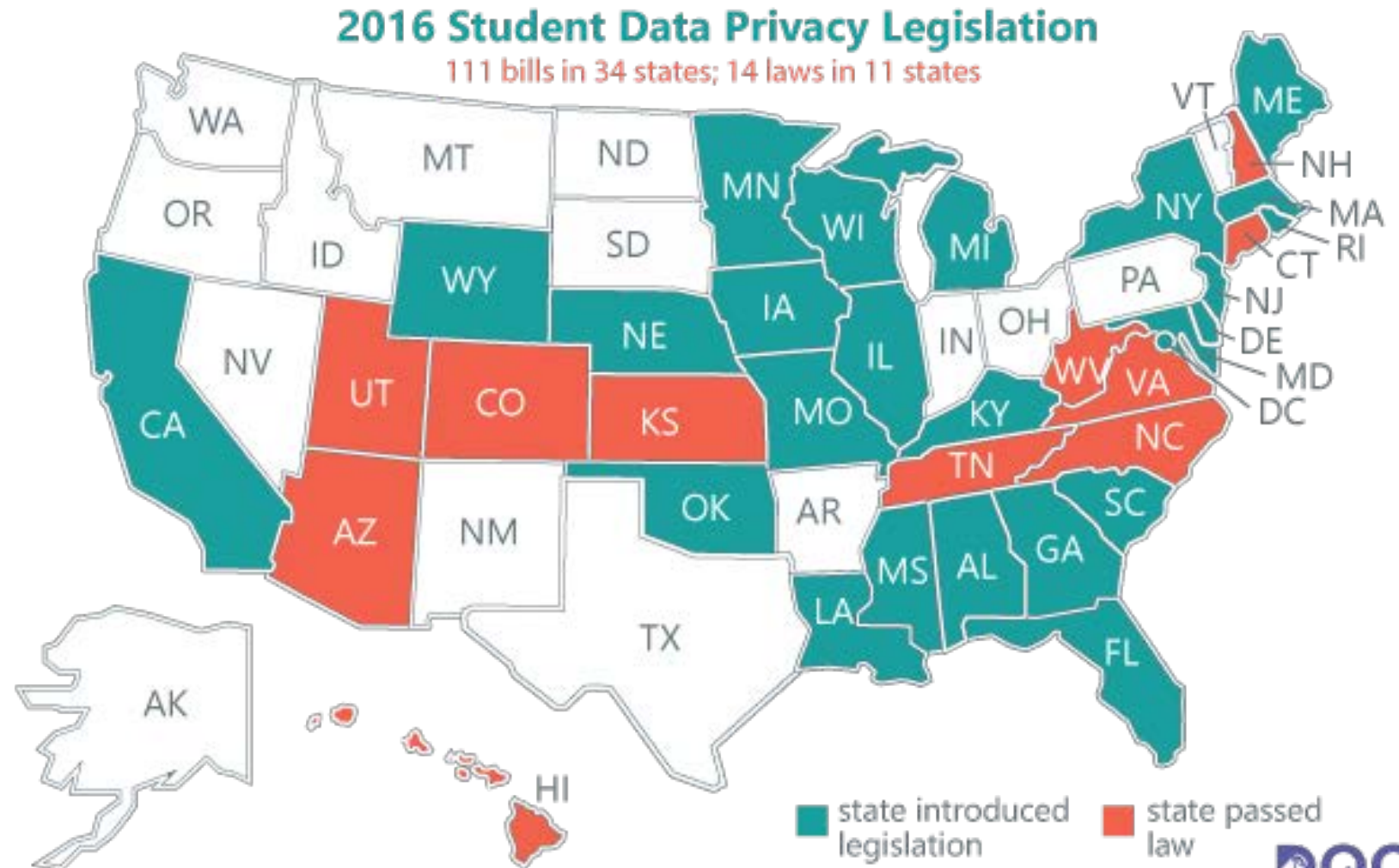
28 laws passed in

Louisiana: A case of unintended consequences

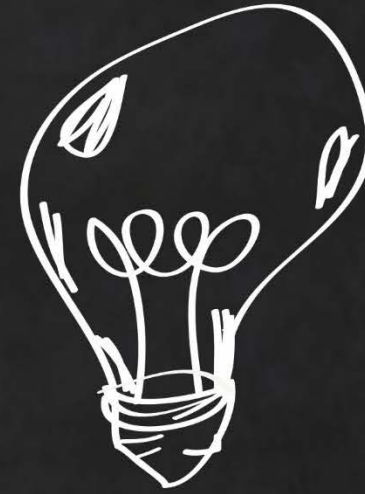

Building a State Data Privacy & Security Policy

- 1. Statement of the policy or law's purposes**
- 2. Selection of a state leader and advisory board**
- 3. Establishment of public data inventory and description of data elements**
- 4. Strategies for transparency about data use, storage, retention, destruction, and protection**
- 5. Statewide policies governing personally identifiable information**
- 6. Statewide data security plan**
